Middle School Enrollment Contract (Returning Student)

2020/2021 Academic Year

Student's Full Name

By signing this Enrollment Contract, I request that Montessori Academy of Cincinnati, (the "School") reserve a place for my student for the 2020/2021 academic year. Upon acceptance of the Enrollment Contract by the School, I understand that my obligation to pay the full, non-refundable tuition and fees of the above student for the entire academic year is unconditional and that no portion of the tuition and fees paid or outstanding will be refunded or canceled in the event of absence, illness, failure to attend, withdrawal from the School, or for any other reason.

Tuition and Fees: Tuition for the 2020/2021 academic year is \$13,120.00*. I understand that I am responsible for payment of the tuition for the entire school year and for other related fees that will be billed to me, including, but not limited to, Field Trip and Activities Fees, and any use of Before- and After-School Programs.

I understand that before acceptance by the School, I must submit the completed Application together with this Enrollment Contract and the first tuition payment in the amount of 10% of the annual tuition (\$1,312.00) to secure my student's place in the School. This Deposit will be applied by the School toward the cost of tuition. Payment of the balance of the tuition is payable in one of the two following options (choose one option):

- Annual Payment. One payment in the amount of \$11,808.00 is due prior to August 1, 2020.
- Monthly Payments. Nine monthly payments of \$1,312.00 are due the first calendar day of each month (August through April). A \$30.00 Late Fee will be assessed for any tuition payments received after the 4th of the month, and every week thereafter.

I understand that failure to make the first non-refundable tuition payment or any subsequent non-refundable tuition payment by the date upon which it is due shall, at the sole discretion of the School, cause the total amount of tuition remaining for the academic year to become immediately due and payable in full.

Policies: I understand that the School must comply with Regulations set forth by the State of Ohio, Department of Education. I understand that I must fully comply by completing all required forms with respect to these Laws and that the School reserves the right to exclude my student from its Programs if I do not do so. Such exclusion does not negate my financial obligations under this Enrollment Contract.

Withdrawal: As stated above, I understand that withdrawal of my student before the end of the school year does not relieve me of the obligation to pay tuition for the entire academic year. However, I understand that should my student need to withdraw, assuming the procedures stated in the School Handbook are followed, the School will use its best efforts to mitigate my obligation to pay tuition for the entire academic year by enrolling a new student to fill the vacancy created by my student's withdrawal, but only after the start of the academic year or enrollment capacity is reached in the program I have noted above, whichever occurs first. After the start of the academic year, replacements will be made regardless of total classroom enrollment. A student will be replaced in the order of parents' notification to the School and predicated upon availability of space, based on age of student and program availability.

I acknowledge that the School shall have the right to pursue legal action to collect unpaid tuition and fees related to my student's enrollment in the School, and that I will be responsible for any and all costs incurred in pursuit thereof, including court expenses and reasonable attorney's fees.

Waiver: I understand that the School reserves the right to waive certain obligations set forth in this Enrollment Contract if it determines that my student should not continue as a student for any reason. The decision of the School at any time to not require performance of any provision or to resort to any remedy provided under this Enrollment Contract shall in no way affect the right of the School to require performance or to resort to a remedy at any time thereafter. Provided further, I acknowledge that I am responsible for the financial obligations set forth above, even in the event of such a waiver.

Agreement: The persons signing below agree to all the terms and financial obligations set forth in this Enrollment Contract, the accompanying Middle School Application, and the School Handbook.
